The amendments to Annexes 1 (except for paragraphs 1.2.4.2 and 1.2.8.2); Annex 2; Annex 4 (except for paragraph 2.4.4); Annex 6, Part I (except for paragraphs 3.3.1 to 3.3.4 and 8.7.3.1 to 8.7.3.4); Annex 6, Part III (except for paragraphs 1.3.1 to 1.3.7); Annex 9; Annex 10, Volume I; Annex 11; Annex 13 (except for paragraphs 3.2, Chapter 8: *Note*, 8.2, 8.4, 8.6, and Attachment F); Annex 14, Volume I (except for paragraphs 1.5.1, 1.5.2, 1.5.3 and 1.5.4); Annex 14, Volume II; and Annex 15, will become applicable on 19 November 2009.

3. Paragraphs 1.2.4.2 and 1.2.8.2 of Annex 1; paragraph 2.4.4 of Annex 4; paragraphs 3.3.1 to 3.3.4 and 8.7.3.1 to 8.7.3.4 of Annex 6, Part I; Annex 6, Part II; paragraphs 1.3.1 to 1.3.7 of Annex 6, Part III; Annex 8 for the State safety programme provisions; paragraphs 3.2, Chapter 8: *Note*, 8.2, 8.4, 8.6, and Attachment F of Annex 13; paragraphs 1.5.1, 1.5.2, 1.5.3 and 1.5.4 of Annex 14, will become applicable on 18 November 2010.

4. Annex 8 for the safety management systems provisions will become applicable on 14 November 2013.

5. With regard to the above-mentioned Annex amendments which have multiple applicability dates, those elements of an amendment applicable in 2009 have been issued as Amendment "XX-A". The elements of an Annex amendment applicable in either 2010 or 2013 will be identified as Amendment "XX-B" and issued next year.

6. The blue cover editions of the amendments to Annexes 1; 2; 6, Parts I, II and III; 8; 9; 10, Volumes II, III, IV and V; 11; 13; and 15, were dispatched in the July air cargo, and Annexes 4; 10, Volume I; and 14, Volumes I and II, will be dispatched in the August air cargo.
